>Mayor Allen stated he could do some of the plumbing work at no cost to the City but asked to be reimbursed for the materials. Council Member Rob Amundson made the motion to reimburse the mayor for the materials and not to exceed \$100.00. Clerk/Treasurer, Marlene Yurek, seconded motion. Motion carried.

>Exterior painting & staining – waiting for spring to get a bid.

>Sidewalk, rain gutters, irrigation system – to be addressed in the spring

>Parking lot across the road from the public landing on Big Trout Lake.

Mayor Allen stated there wasn't any funding for the parking lot.

>Property across the road from the Manhattan Beach Lodge.

Mayor Allen stated there would be a planning & zoning meeting in January to review the ordinance regarding storage buildings in the City of Manhattan Beach.
