

*MINUTES OF THE REGULAR MONTHLY MEETING

The regular monthly meeting was called to order at 7:00 PM by Pro Temp Mayor Elizabeth Worts. The following officers were present; Council Member Mike Dozark, Clerk/Treasurer Marlene Yurek and Pro Temp Mayor Elizabeth Worts. There were 9 (nine) residents, 1 (one) business representative in the audience.

The Pledge of Allegiance was recited.

APPOINTMENT OF COUNCIL MEMBER: There were two (2) letters of intent, Peg Boots and Isaac Wannebo. Council Member Mike Dozark stated Peg was qualified to fill the vacancy with the council as she had served on the council in the past as well served as the city clerk. Clerk Marlene Yurek stated Peg was qualified to serve on the city council based on her experience. Pro Temp Mayor Elizabeth Worts stated Isaac Wannebo was on the ballot for a position on the council. Pro Temp Mayor Elizabeth Worts asked for a motion. Council Member Mike Dozark made the motion to appoint Peg Boots to the city council vacancy. Clerk Marlene Yurek seconded the motion. Motion carried. Clerk Marlene Yurek swore Peg Boots into the council seat.

AGENDA AMENDMENTS: There were no agenda amendments. Council Member Mike Dozark made the motion to approve the agenda as printed. Clerk Marlene Yurek seconded the motion. Motion carried.

Pro Temp Elizabeth Worts stated that issue would be tabled until the next meeting.

ORDINANCE NO 09-26

AN ORDINANCE FOR THE CITY OF MANHATTAN BEACH
ELECTED OFFICERS SALARY COMPENSATION

MAYOR:

The term for Mayor shall be two (2) years.

The Mayor shall receive \$450. per meeting plus \$150, for special meetings.

(Effective January 1, (2027)

CITY COUNCIL MEMBERS:

The term of City Council Members shall be four (4) years.

The Council Members shall receive \$400. per meeting plus \$150. for special and extra meetings. (Effective January 01, 2027)

CITY CLERK TREASURER:

The term for City Clerk/Treasurer shall be four (4) years.

The City Clerk/Treasurer shall receive \$850. per month. The City Clerk/Treasurer shall receive \$400. per city council meeting plus \$150. for special and extra meetings. The City Clerk/Treasurer will receive \$150. educational meetings. (Effective January 1, 2027)

PLANNING AND ZONING:

The Planning and Zoning members will receive \$150. per meeting.

(Effective January 1, 2027)

Salaries are to be reviewed every two (2) years.
